This has been quite a year for Rockford Sexual Assault Counseling! While there have been challenges, I want to share the wonderful that's been happening with you all!

To begin with, as the year has gone on, RSAC services have continued to return to a more normal, pre-pandemic place. While we still offer telehealth and phone counseling as ways to provide options for clients who do not feel safe coming in-person, we are seeing an increase in people coming in-person and a huge increase in the amount of Prevention programming in the schools this year. I cannot stress enough how important it is to have our Preventionists in the schools doing the Erin's Law presentations (an



Illinois state mandate that teaches about sexual assault/abuse and consent in age appropriate ways for our pre-K-12<sup>th</sup> grade students). What we know is when Preventionists are doing in-person presentations, they often receive disclosures from kids who have been sexually abused/assaulted. Once that disclosure happens, those kids can get the help, support and protections they deserve!

We've also been fortunate that we are fully staffed and have added four new, wonderful people this year! This includes two Preventionists, a Volunteer Coordinator, and a Therapist. As I look around RSAC and the people who work here, I always feel very fortunate. We have a wonderful, caring, hard-working team here at RSAC, and I'm very proud of that!

I also want to give a huge shout out to our volunteers! These dedicated individuals give their time, talent and efforts to RSAC, and the survivors we serve. At a time when the world is so different, we appreciate that they still serve as volunteers in many different capacities as medical advocates, board members, office assistance, public awareness, fundraising, and more. We cannot do what we do without them, and they are an integral part of our RSAC team!

RSAC has also held two fundraisers this fall/winter (pg 4 & 5) and the support we received from businesses and community members was so heart-warming and appreciated!

As we go into the holidays and new year, RSAC has so much to be grateful for and you are a part of our gratitude! Take care and happy holidays to you all!



#### Volunteer Advocate Spotlight

#### Blake Heinzeroth

Hello! My name is Blake Heinzeroth and I'm a male advocate/volunteer here at Rockford Sexual Assault Counseling. I went through my advocate training in July of 2017, so I'm going on my fifth year with the organization. I first decided to become involved with RSAC because of all the disclosures of abuse and assault that my friends had shared with me over the years. I have always been struck by the pervasiveness of this issue and as I listened to story after story, there emerged some very common themes: self-blame, anxiety, struggles with self-esteem, and just general unresolved trauma to one degree or another. I've always endeavored to give my friends a safe space to talk about these issues, but I was excited to find an organization like RSAC that could offer a more formal,



therapeutic approach and provide healing in a way that I was unable.

If I'm completely honest, I had some trepidation about joining at first. The sexual assault advocacy space can be notoriously female-centric, and I knew there were only two other male advocates in the organization when I signed up. But, I am a firm believer that men play a significant role in the reduction of sexual assault, and their voices are an important part of the discussion. I was relieved to find that I was immediately welcomed with open arms and have had nothing but positive experiences with everyone in the organization. These are all people who genuinely care about what they do, and one of the personal benefits I appreciate is being surrounded by people who feel as passionately about this topic as I do.

There are many pre-determined ways for male advocates to support RSAC's mission including signing up to staff the RSAC booth at various events like the Boone County Fair (again, I feel like having a public male presence sends the message that men are in a unique position and have a distinct responsibility to address sexual assault), volunteering for the annual candlelight vigil ceremony, or participating in the quarterly advocate meetings. I've also enjoyed the challenge of generating new ways to support the organization, whether that be via reimagined methods of fundraising, creating ways for survivors to safely interact with RSAC (our QR code project which allows survivors to carry hotline contact information on encoded cards without alerting an abuser is one example), or writing articles like this for the newsletter.

No matter who you are, if you are passionate about helping survivors of sexual assault and reducing its occurrence in the first place, we would love to hear from you!



Rockford Sexual Assault Counseling, Inc. recruits volunteers to provide advocacy for victims of sexual assault or abuse and their families. Volunteers play an important role in helping victims feel they are not alone and not to blame for the assault or abuse.

Our agency provides a 40-hour training session for all volunteers. The topics discussed will include, but are not limited to: basic advocacy techniques, the Illinois Criminal Sexual Assault Law, medical care of the victim, crisis intervention, child sexual abuse, and community resources.

Volunteers providing advocacy play a crucial role in providing crisis intervention services to victims of assault or abuse.

Requirements for becoming an RSAC volunteer:

- At least 18 years old
  - Background check
- Available for on call two weekday evenings a month or one weekend day a month
- Have reliable transportation with insurance
  - Have a phone

Fee for training class is \$40 to cover materials.

Scholarships are available.
